2. SPECIFIC MATTERS FOR CONSIDERATION BY THIS MEETING (ASSESSMENT)

- 2.1 Since the last Committee meeting Members should note:
- 2.2 My appraisal with the Minister will take place on 27 January. The Committee will be updated on any outcomes at the meeting.
- 2.3 All Wales Chair's meeting: The Chair has attended All Wales Chairs' meetings on 26 November 2019 and 7 January 2020. At the latter meeting the Chairs were notified of Welsh Government's considerable concerns over the perceived lack of progress with regard to developing alternative pathways. The Chairs believed that work was taking place but accepted that there may have been a lack of co-ordination and pace in this work. I offered the services of EASC to help co-ordinate and progress this work and this was gratefully accepted by all parties and I therefore wrote to Andrew Goodall to confirm this. Subsequent to this Andrew Goodall has asked that the work on alternative pathways be incorporated into the work of the Ministerial Ambulance Availability Taskforce (for discussion at the meeting) and that we produce an action plan by 31 January. The CASC and I have also held a helpful meeting with the Chair and Chief Executive of WAST to agree some operating principles for this work.
- 2.4 The programme of visits to Health Boards has continued with meetings at Cwm Taf Morgannwg (28 November 2019) and Powys (10 December 2020). Once again we received constructive feedback on both occasions.
- 2.5 I have continued to attend Management Group meetings as an observer. This is helpful to me personally in meeting colleagues from Health Boards and hearing about different perspectives but I have also been able to observe how the group is developing in terms of agenda setting and the framing of advice back to EASC etc.
